Dietetic Practice Education Update

Sharing developments and best practice with those involved in Scottish dietetic education

Practice Educator Evaluation of Placement A

Following the review of dietetic practice based education and the introduction of new learning outcomes, competencies and assessment tools in Scotland in 2016 we are beginning the evaluation process of the changes that have been made. We are starting with the evaluation of placement A (placements B and C will be evaluated in due course) and will be surveying both students and Practice Educators. We welcome comments from individuals and/or departments so we would be grateful if you would circulate the link widely within your teams. The survey will be open until midnight on Sunday 14th August and the feedback we receive will be used to inform the placement cycle for next year

Placement Demand 2017

Placement type	Weeks	Comments
A placement	160	Includes 4 weeks for 2 x students who previously deferred studies.
B placement	924	Includes 48 weeks for 4 x students who previously deferred studies; 12 weeks for 1 x student not progressing as expected and 12 weeks for 1 x student requiring extended weeks
C placements	948	Includes 48 weeks for 4 x students who previously deferred studies; 12 weeks for 1 x student not progressing as expected; 36 weeks for 3 x students requiring extended weeks and 24 weeks for 2 x students displaced from their originally allocated 2016 placements.
TOTAL	2032	4 weeks less than 2016 demand

The 2016 placement cycle saw a higher than usual number of placements being cancelled/withdrawn by Practice Providers. This has therefore had a direct effect on placement demand for 2017.

Practice Placement supply requests will be sent to Lead Practice Educators at the beginning of July 2016 with a request that supply offers be returned to Pamela Knox, Scottish Dietetic Placement Administrator, by the end of August 2016.

Please note that for 2017, Health Boards have again been given guidance on the number and type of placements required and the timing that placements are required. It is hoped that by doing this, fewer requests will be made to Health Boards to change the timing of the offers made.

Lead Practice Educators will then be informed of all 2017 allocations by the end of October 2016 at the latest.

Implementation and Evaluation Timescales

This is just a reminder of the timescales for the piloting of the revised placement model, and the planned evaluation periods.

Placement	'Pilot' cohorts	Reflect and revise
A	January & Summer 2016	August 2016
В	April, July & September 2016	November 2016 - April 2017
C	July & October 2016	April - July 2017

Please remember that students accessing B and C placements in 2016 will not have undertaken the new Placement A tasks and activities.

Have you been delivering a placement or using the new portfolios and come across a task that needs a little more explanation, or perhaps an annoying spelling error? We'd like to hear from you.

We have set up a dedicated email address to enable you to 'post' your observations, comments, suggested changes etc. to the placement documentation and tasks. These should not be specific to any students that you host on placement, but should relate to the placement materials that have been under review. The email address is acting as a repository for all information until the review stage of each placement. At this point, we will collate the information and identify what actions, if any, should be taken for the following year placement cycle.

Student Progression 2016

The universities collect data on student progression through practice placements. Data below relates to the 2015 placement cycle

Placement A

70 students proceeded to and completed placement A.

Placement B

Of the 70 students who were allocated a B placement one student transferred to another course. All other students progressed after the normal 12 week placement.

Placement C

Of the 71 students who proceeded to placement C, six students failed to successfully complete within the 12 weeks allocation. Of these students two were required to repeat the placement and four were required to undertake additional weeks. One student has successfully repeated their placement, and another student has been successful in her additional time. The remaining students are still to be allocated the additional time they require.

In addition to the information above data is also collected regarding location of placement, location of additional weeks or repeat placement, number of additional weeks required by the student and outcome of those additional weeks, length of time between placements, and location of previous placements. Each Health Board area can access data relevant to their health board area. If you wish this information please contact either your link HEI or Jacklyn Jones (Lead for approval and monitoring).
